- 1. All accounts are due and payable on 30 days following date of invoice.
- 2. Interest will be charged on overdue accounts at the rate of 2% per month (24% per annum) and compounded monthly daily from the time it first accrues until payment is made (notwithstanding any judgment or attachment or other process of law taken against the credit applicant in respect to such invoice of account).
- The credit applicant shall be responsible for the full amount of all proper and reasonable costs, expenses and fees incurred by The Company to affect
  collection of overdue accounts.
- 4. Payment shall apply first against the interest and other charges owing and then to the balance.
- 5. In the event the account becomes overdue, all accounts, including dating invoices, shall at The Company's option become due and payable immediately.
- 6. No goods are returnable without prior authorization from The Company. Authorized returns are subject to a restocking fee.
- 7. The customer consents to The Company or their solicitor making an investigation and/or obtaining a credit report.
- 8. Notwithstanding that invoices may be issued in the sole name of the corporation, the Corporation and the principle shareholders acknowledge and agree that they will be responsible to repay, as principle debtors, any balance outstanding on a joint and several basis.
- 9. The omission of information or alteration of these terms and conditions may delay processing of your application or may be grounds for denial of credit.
